The Hospital will be closing on November 28, 2019, and the Behavior Health portion will continue to operate in this building until further notice. There are only two rooms that we can use in this building. Prior to the closing notice, I was allowed to reserve the Thiesen room for H&I. Our Human Resource Panel (HRP) has a deadline of September 30 for those interested in being part of HR. Submission of Application is necessary. Please see me if you would like more information.


Our World Service Conference is upcoming in April with the continued submission by Regions of any and all topics related to motions or Idea Requests. At this particular time this report has no submissions to submit.

I have submitted a request for a certificate of insurance for the convention.

ARCNA Treasurer, Jason L, & I met with ARSC CEO & CFO at Bank of America and completed the paperwork for the new checking account. We are currently waiting on the debit card to be delivered. Checks have been issued & received.

The 1st fundraising event is being planned. The original plan for this event was a yard sale. There was a lot of concern raised as to whether this event would be in violation of the 7th tradition. I spoke with many members with 20+ years of clean time and significant experience in NA service. Although they each said, to a man, that this type of event was not in violation of any traditions, I was urged to reach out to WSO. Our new book, Our Guiding Principles, which as you know is a group conscience says that although this type of event is not in direct violation, it is suggested that we steer clear of this type of fundraising. ARCNA 34 wishes to generate interest for the convention in a positive way and this event seemed to be creating heated conversations and negativity. Therefore, in the interest of unity, the yard sale has been canceled. We are notifying the fellowship via FB and announcements.

We are planning an event for the same date, Dec 7. The fundraising & entertainment committee is meeting today to plan the details. Due to the late start of this event and its circumstances, We hope the members of this committee will plan to attend, bring their tribes and support this event. Flyers will be available this week once the details have been solidified.

The registration fees are still being worked out. We expect the rates to be considerably less than in years past. Registration will open the first week in December.
