Good morning area! We had our NYE event and it went great! A good time was had by all who came. We now have all of the supplies in order to put on another casino night any time, we can keep them and do it annually or something or sell it on facebook marketplace or something if wanted. After both approved amounts, we had a budget of \$1900 and spent \$1,878.02. I forgot I needed to reimburse for two receipts the day off and we actually went over by \$12.46 but after the event I was able to return unopened apple ciders to Costco and get money back. So this left us with \$28.30 to return to area from the original budget. We had close to 60 people in attendance.

He showed me one that he thinks would work for our events in a bundle and said with this lower end of professional bundle we would probably get away with one column speaker but may want two in the case of events like the May event we had. The total for this bundle with a speaker/mic/stand/ and mic cable is \$1,089 plus tax and shipping im sure. An additional speaker is \$949. I have attached the link in my email and brought a printed copy to share. This is something that I think our area should absolutely invest in since we have the money. There are a few other small things I have thought of off the top of my head that we need but I was thinking when we do the inventory, we could come up with some more things that activities could use to help spend some money to improve our activities thus better carrying the message to addicts. I

need to know when some people are available to help with this inventory. I also would like to say now that some of my time is freed up I am willing to work on a set of Activities guidelines with a small group for the next person if that is still desired as I never got to it this past year. Another thing to consider if we do buy the PA system is that we will definitely need a larger storage unit, Which would honestly be a good thing to help things be easier to get to.

Overall it was a great year of service and part of me is sad to leave the position but I can not run again at this time. I appreciate you guys letting me be of service and I am so grateful to the committee members who showed up and made these events happen! Thank you all!
