It was super awesome to have Jesse attend the virtual meeting with me in January. His interest and excitement for service is inspiring and I am very grateful for him jumping into this role.

Here are the noteworthy highlights from Region:

### Regional Minutes

RCM's have been requested to attach the regional minutes to our reports. I have attached the .pdf that SHOULD NOT BE POSTED on the website. I wanted to include this because there have been many questions about the regional finances and there is a treasurer's report in there. There is also I link to the redacted version of the minutes that I cannot find a link to that CAN be posted on our website with our minutes.

### Spring Assembly

Will be held on Sunday April 13 in Casa Grande. Please encourage your GSR's to attend. There will be a GSR training workshop that I am helping to facilitate, so it would be super nice to have support from the peeps in our Area. I know we have it in our policies to do one of these for our Area, but it would be great to see more of our Area GSR's meeting more of the Regional Service Body. This also might help encourage or interest members to take regional service commitments in the future. We could also discuss using some of our monies to pay for the gas or reimburse members for mileage to get to the event if there are concerns about costs. Jesse and I will be attending and I think we are planning on carpooling, so we can take a couple people with us who would like to go.

### Event and Meeting Insurance:

There will be issues getting meeting insurance approved if the meeting information does not match! (Date, time, location, etc). 4-6 weeks advance notice for Insurance for events and a little bit less for meetings. From the insurance side, we used to have a single POC, and now there are two separate ones for meetings and events. The person handling the events has not been responding as we had hoped. Greg has called their corporate office and left messages and the POC isn't responding to calls or emails. It might be in the contract that we are auto-covered and then charged at the end of the year, but we need actual confirmation of that. Meeting Certs need to have matching info for the meeting list and also provide a contact phone number for the facility. Meetings are automatically covered if they are on a meeting list. They need to be on the list before the cert is requested. Meeting certificates will no longer have an end date (they are trying to do this so they don't have as many new certs that are needed. Site locator is responsible for finding future ARCNA sites. Only have a contract for this year, not next year. Final decision should be ready in May. More to come on this.

There was a lot of discussion about this and the concept of a single point of accountability (the webmaster) and ultimately it was decided not to make the changes since ARCNA already has their own website and the convention info is prominently placed on the top of the regional website.

**Discussion regarding absorbing old NA website domain** that was used for public information and that decision passed to PR committee to decide what to do with the information there.

Regional inventory before or after in-person ARSC meeting + facilitator- tabled until the next meeting because we needed additional info about the cost for the facilitator to come. It will be very cool to get to participate in an Inventory at the regional level with an outside facilitator if we decide to go that route. I think that this will help us to better understand how to facilitate an inventory for our Area. When we did ours, only about half of the groups responded. The results from that are attached.

We have filled the Activities Chair and have an upcoming event on Feb. 24 for Home Group Trivia! It should be a super fun time, so please announce at your meetings and get your homegroup involved.
