Trusted Servants Reports: I am excited to announce that the Regional H&I Subcommittee has released its first ever t-shirt which I am in possession of in limited quantities due to them being sold across the entire Arizona Region. We are selling them for \$30 and the proceeds will be used to purchase literature (not only basic texts but How It Works and Why, Just for Today and Living Clean, as needed). Being that this is the first time there were no archives of past orders, quantities, etc. to base our initial run off of. There was an approved amount by Region to purchase 70 shirts with the expectation of repaying the seed money and if needed, more funds would be provided for future orders. Please see me if you are interested in purchasing one. Our subcommittee is in the process of revising our H&I guidelines having held an Ad Hoc meeting last month and will hold another meeting of the minds prior to our next monthly subcommittee meeting on 10/26. We feel confident that by November's meeting, we will have them revised for final approval. We discussed at our last meeting how we can ensure that every member is aware of our need for volunteers to go into the new Prescott Jail. We ask that all GSRs report back to their respective home groups and announce it during their reports. We currently need male volunteers and will seek female volunteers once they have a population of female inmates on this side of the mountain. To be approved to volunteer, you must complete an application and submit it to the local jail or they can be emailed to the coordinator out in Camp Verde. If any member has been approved to go into the Verde Jail, please get with me for the coordinator's contact info to reach out and see if you are still approved. Sharing this message is vital for our ability to share our message inside our local jail. With the year coming to a close, I am grateful to be handing over the subcommittee to a but trusted servant who I am confident will continue the valuable message through H&I that I find so near and dear to me. Continuing my recovery journey, I will be remaining on the H&I subcommittee and continuing to carry the message in our local community. I look forward to serving our fellowship in other areas.
