- Bailey G – concerned about the style of the Journey Program and whether its format is really considered H&I and if not how can we make it so as we are seeing addicts come to NA from what

is going on there. It is currently a panel every other week in 8 or so week sessions. The coordinators picks a small panel that commits to every other week for each 8 week session. They have 4 -5 meetings with the juveniles in the program and have discussions based on topics. Concern is whether this becomes more of a school or clinical type of session rather than a true h&l panel and if so what could make it qualify yet keep it successful. Discussion was had on this and Aaron S was asked to bring back a list/schedule of what the meetings look like. TABLED
